DURING THE YEAR ENDING JUNE 30, 2016, EVA'S HAD 103 AVAILABLE BEDS FOR MEN, 36 BEDS FOR WOMEN, AND 24 BEDS FOR WOMEN WITH CHILDREN. THE PROGRAM SERVED 228 MEN, 79 WOMEN AND 44 MOTHERS WITH CHILDREN. THE OUTPATIENT RECOVERY AND BEHAVIORAL HEALTH PROGRAMS SUCCESSFULLY TREATED OVER 914 INDIVIDUALS DURING THE YEAR ENDED JUNE 30, 2016.
